The March Trip 3 – 10 March 2025 will be to the Ingenia Caravan Park at South West Rocks. The park is pet friendly. The Committee are looking for parks which are pet friendly and have cabins.

#### **General Business**

Bev Shoobert spoke about the <u>"Emergency + App"</u>. It has contacts for 000, SES and Police. Just touch the little icon in the App and the number is dialled for you. Your position in latitude & longitude plus a little map identify where you are. On the bottom of the screen is "what3words" followed by 3 words. Those words will give the call centre operator your position also. The service does not require phone service, it connects to a satellite and is a <u>FREE</u> App.

Bill McConville spoke and suggested that when a member would like to attend a trip and they are not quite well enough to drive, that a member offer to drive their vehicle and van so that they can attend. This would help them remain active in the club.

Shirts – Joan Cornwell asked that someone be in charge of the Club Shirts. Bev Insull has agreed to do this.

Janis Treacy spoke about the medical information sheets and she offered to laminate them as she had the laminator at the meeting.

Ian Palmer re Hema Maps: Ian told the meeting that the latest Hema Maps showed the "what3words".

AED: Ian said that a recent medical examination rules him out of operating the AED with CPR. Many of us would be in the same position without the strength to carry out the CPR. All members please consider if we need the AED. If we don't need it, we should donate the AED and Training Unit to another group. Life Saving Clubs in the area are requesting donations to purchase these. The AED requires updates every 5 years. We have had our current AED for 3 years. It is currently taken on 3 Club Trips. All caravan parks have an AED. The Good Samaritan Act covers any volunteer carrying out the operation of the AED and CPR. The machine gives instructions on use. Aado Maranik said that substantial caravan parks should have AEDs. He suggested that none of those at the meeting were capable to carry out the CPR and the machine should be donated.

**Motion:** Jan Ryan moved a motion that the AED be taken on all trips. The trip leader will be responsible for signing for it and return and sign for its return.
